
Don't Let Your Savings Accounts 60 to the State!

If your credit union account has no activity for three years, your account will be subject to a Pennsylvania state law called "Escheat." This law requires that the funds be transferred to the state each April.

While we will attempt to notify you before this happens, we recommend making either a deposit or a withdrawal if you have not had any activity within the last three years. This will activate your account & keep it from going to the state. You may also notify us to update your account information as well.

This also affects other accounts in your name in the State of Pennsylvania as well. You can check the PA Treasury website for any unclaimed property or funds that have been previously sent to the state on your behalf and begin a claim to recover your money:

H's Officially Tax Season!

When you are preparing your 2023 taxes, you will find your Freedom United FCU Account year end dividends at the bottom of your December 2023 statement.

Your 1099-INT form will be sent to you no later than January 31, 2024. Please be aware that 1099-INT's are only filed on interest paid over \$10.00 for the tax year.

Helpful Tip: If you choose to have your refund direct deposited to your account, you will get your refund faster! Contact the credit union for the proper account numbers.
